RULES:

- Vendor fee is due with completed application. Payments accepted at the Cultural Center Gift Shop.
- **ALL VENDORS** must have a Yakama Nation DOR vendor permit. Pursuant to R.Y.C. Chapter 30.02.21.
- Vendors will receive their assigned booth space number via phone call and/or email from CHC Admin staff. (No reserved spaces).
- Vendors **MUST** set up in their assigned numbered space.
- Standard 10ft x 10ft booth space (numbered). No shades, chairs, or tables will be provided.
- Vendors must supply their own equipment (examples: 10ft x 10ft canopy, chairs, tables, etc.)
- The vendor number and vendor permit must always be displayed in plain sight.
- CHC Campus map will show designated setup areas for vendors.
- A single parking pass will be issued to eligible vendors for ONE vehicle.
- Parking passes are not transferable.
- Parking passes will be available the day before the event for pick-up at the CHC Admin building on 6/6/24.
- Setup time starts at 7am. Breakdown starts at 2:30pm.
- All vendors are responsible for proper breakdown and cleaning of their booth space at the end of the event. (Please dispose of trash in nearby cans/bins.)
- There is **NO** electricity provided and we will not allow extension cords to/from our buildings.
- **NO** generators or propane stoves/tanks near buildings permissible.
